2 Policy Objective

To delineate the areas of responsibility for the management and operation of Dalton Park between the various interested parties.

3 Policy Statement

Council undertakes and maintains services other than those provided for the exclusive use of the respective clubs.

The areas of responsibility are generally as follows:

Griffith Harness Racing Club Inc.

- Maintain harness racing track, lights and all equipment associated with harness racing;
- Be responsible for grounds and buildings associated with the club; and
- Maintain appropriate insurance policies in relation to Dalton Park Buildings as stipulated in the Licence Agreement together with a Public Liability Policy (not less than \$20 million) with GCC and Department of Trade and Investment - Crown Lands Division listed as an “Interested Parties” on the policy.

Griffith Jockey Club Inc.

- Maintain the sand and grass tracks;
- Be responsible for the mowing and watering of tracks and the extended Licenced area as required and be responsible for all equipment associated with the running of the club;
- Be responsible for the club’s storage facilities and buildings; and
- Maintain appropriate insurance policies in relation to Dalton Park Buildings as stipulated in the Licence Agreement together with a Public Liability Policy (not less than \$20 million) with GCC and Department of Trade and Investment - Crown Lands Division listed as an “Interested Parties” on the policy.

Griffith/Benerembah Pony Club

- a) Be responsible for the maintenance of grounds and buildings associated with the club; and
- b) Maintain appropriate insurance policies in relation to Dalton Park Buildings as stipulated in the Licence Agreement together with a Public Liability Policy (not less than \$20 million) with GCC and DPI - Crown Lands listed as an “Interested Parties” on the policy.

Griffith Riding for Disabled

- a) Be responsible for the maintenance of grounds and buildings associated with the service; and
- b) Maintain appropriate insurance policies in relation to Dalton Park Buildings as stipulated in the Licence Agreement together with a Public Liability Policy (not less than \$20 million) with GCC and Department of Trade and Investment - Crown Lands Division listed as an “Interested Parties” on the policy.

Griffith City Council

- a) Council to collect all rates payable at the complex;
- b) Mow and maintain the enclosure area;
- c) Supply all equipment for the maintenance of the enclosure;
- d) Maintain all internal roads, boundary fence and fire breaks;
- e) Maintain the water supply; and
- f) Maintain and equip the Dalton Park Dining Room, this can be booked by any member of the public through Council’s Bookable system.
- g) Undertake routine inspections of all areas at Dalton Park to ensure compliance with this policy.

Private Lease / Licence Holders

- a) Maintain all areas in the private lease lot;
- b) Restriction of 2 private lease lots per individual;
- c) Private lease holders are not permitted to sublease.
